



3rd Annual *Buffalo Jump* 1/2 Marathon, 10K, 3 mi walk

Location: First People Buffalo Jump (formerly Ulm Pishkan State Park) in Ulm, MT Exit 270 off of I-15 follow signs 3.5 miles to the park. Only 10 miles south of Great Falls.

Date: Sunday May 23, 2010

Race Distances: 1/2 marathon and 10K run; 3 mile walk

Race Start Times: 9 a.m. for the 1/2 marathon and 9:45 a.m. for the 10K run & 3 mile walk

Race Course: Soft, rolling, dirt and paved roads near the First People Buffalo Jump in Ulm with beautiful views of Square Butte, the Big Belt Mountains, & the Little Belt Mountains
